Bylaws/Town Hall meeting: The meeting on February 15 2023 was well attended. It was the first of two public meetings to review the purpose burning ByLaw that also deals with restrictions on industrial activity in high and extreme fire conditions. The next meeting will be held Saturday March 18 at 1 pm at Albert Reed memorial Fire Hall #1.

Operational Review: The Fire Department has received the Operational review from Jay Brownlee and Associates, I would like to pass it off to the Trustees for their review of the document before making it public.

Grant application: The Fire Department is pleased to hear that we were successful on the Community Emergency Preparedness Fund for close to \$30,000.00. The grant will be spent on the first phase of our structural protection trailer. A structural protection trailer has equipment such as: pumps, hose, portable tanks and sprinklers to protect structures from on coming wildfires. The structural protection unit protects structures by creating a humidity bubble around the threatened building and defending them from radiant heat and an ember cast storm. We are also hosting a course instructed by BC wildfire service called the SP115 which trains us to use the structure protection units.

Asking for Motions:

I would like a motion from the Trustees to set up a Committee to meet on adopting recommendations for the Board of Trustees from the operational review.

I would like a motion from the Trustees to purchase the equipment for the structural unit out of the capital reserved then repay the funds back once we received the grant.

Diana Moher motioned, "Set up Committee to review and adapt recommendations in regard to governance of the Trustees" Sean Lewis seconded. Discussion. Paul Giffin amended the motion "Committee be formed to review the report, and deal with any comments that deal specifically with Trustees and not operations" Fred Apstein suggested an amendment to the amended motion, "Appropriate for the Trustees to review the entire document". Further discussion ensued with respect to Trustees reviewing and implementing recommendations from the review. John Moeller suggested clarifying the motion to, "Accept document and agree to review. Further decision after that point." Original motion that was seconded was retracted. Sean Lewis motioned "formally accept the review" Chris Windess seconded. Carried.

Fred Apstein motioned, "To use funds from capital reserve to pay for the equipment received, and reimburse capital reserve when the grant money is received." James Arends seconded. Carried.

At the request of the author, Paula Mallinson, Chairperson Giffin read aloud their letter:

GFPID

Attention: Paul Giffin, Chair

I attended the March 2023 Trustee Meeting and was enjoying the way it was moving along so smoothly. Unfortunately two things were brought up which I feel the Trustees need to address.

1) At a Trustee Meeting prior to March, Bob Rooks had his employee toss copies of Robert's Rules on the table in front of each Trustee, when asked what he wanted he said for the Trustees to act as professionals and do their jobs. Yet, he himself totally disregarded the rules when he invited a select few Trustees to a meeting of contractors who were going to be discussing the Burning Bylaw, the Chief had volunteered to go to this meeting and was told he wasn't invited. Our Bylaws and Robert's Rules state requests of this kind are to go through the Chairman, therefore no Trustee should have attended this meeting without informing the Chair and the other Trustees. The proper procedure would have been for Bob to to through the Chair and request a delegation be sent to this meeting, he could request certain Trustees but it would be up to the Board. I heard the comment that "I went as a private citizen" and Fred Apstein stated that Trustee's can go to anything as "private citizens", this is true as long as topics about the Fire Department or GFPID are not on the table for discussion, otherwise the Trustees are not acting as a whole, as stated in the Improvement District manual.. In the past few years this belief has been stated before so I believe it is time for a policy to be written in order to avoid confusion in the future. Topics could include, has procedure been followed, what is the topic under discussion, would I have been invited had I not been a Trustee.... I am

sure that Sean and the other Trustees that were invited to attend this meeting did not realize the Fire Chief had offered to go and was rebuffed as they would have realized that their attendance would be undermining the Fire Chief and show Bob Rooks that he can flaunt the rules and get away with it. As to the public's perception of a Contractor asking a select few Trustees to a meeting, it looks bad and questions could be asked as to why these Trustees and what was the purpose, this is especially true for Sean as Bob Rooks has already asked, in a public meeting, for Sean to be the person to inspect his burn piles instead of the Fire Chief, Sean explained that this was not possible, but Bob's continued attempts to bypass the Fire Chief is concerning.

2) Fred Apstein, once again brought up what should have been an in-camera topic into the public meeting, this should never happen. This has been under discussion for over a year and quite frankly everyone is tired of it, especially as some people are coming in at the tail end so have no idea what it is all about. It is unfortunate that Fred doesn't like what the majority of the Trustees decided, as noted in the in-camera minutes, but for him to go on a rant against the Chair, stating he doesn't trust him and calling for a 3rd party to be brought in is what makes people say the Trustees are dysfunctional. As far as I understand, from the meetings I've attended, is that this matter is finished with, I would suggest that this be laid to rest as it is making the meetings unnecessarily long and putting distrust of the Board into the Public's head. Allowing in-camera information into a public meeting is setting a dangerous precedent, it could be argued that anyone who was not happy with the results of the Board's decision to their complaint could bring it to a general meeting to be re-visited, while it has always been accepted that in-camera stay there it would seem that a policy needs to be done for this as well.

April 1 is the start of the fire season and we have had our first grass fire. This is a reminder any fire larger than a campfire requires a permit. All fires require property owners to have water onsite.

BCEHS has given the Gabriola Fire Department a service agreement to provide emergency medical responder services to Gabriola Island. Currently our medical director is reviewing the agreement. Gabriola Island is one of the first in BC. to have an agreement in the works.

Spruce Rd had three motor vehicle incidents over the winter months. I have been in talks with MOTI for more signage, to slow traffic as well as physical barriers on the corner near rivers place to stop vehicles from ending up in the very deep ditch.

After a communication outage at the end of November, I have been working on ways to improve communications. I have found a repeater frequency which will work in all parts of Gabriola for the emergency agencies to stay in contact if phone and internet are not working.

FireSmart drop-off days were a huge success, removing 400 yards of debris from residents' yards, improving the fire safety in priority zone 1 which is 0-30 feet out from a home.

The Structure Protection Trailer that we established through the emergency preparedness fund is ready to protect Gabriola this summer. We are finalising the rest of equipment and storage before it's out in the community to do more training.

The bush truck is now ready for summer - #4. The bush truck just switches from winter mode as a snow plough to summer mode as a bush truck for summer.

B.C. Wildlife service will be coming over to Gabriola for a couple days to do some maintenance of fire access roads that run through the 707 park. This is an annual event where we host the service at the fire hall and run cross training evolutions.

Training Officer Report:

 and Jenn is working on having another evaluator attend to finish the rest of the class.

Regular Training:

- Wildland Fire Training for the entire department all month. 10 new members qualified for BC wildfire Certification, and all other members passed required annual re-training
- All members now qualified as Emergency Traffic Controllers by BC Municipal safety association (taught in house to external standards and accreditation)

• Live fire training was held at the south end behind Hall 2. This live fire evolution allowed our members to fully qualify as structural wildland firefighters, and give us a chance to try out our new pumps and equipment trailer.

Other:

- new recruit class 10 members have been registered with Vancouver Island Emergency Response Academy for in house 1001 firefighter training and have begun our 1-1.5 year training program.
- Glenys and Oliver Bussler are both newly qualified 1001 as professional Firefighters-GVFD trains to industry standards and is accredited by "Proboard" which is the North American Standard for Firefighting- This means our frontline Firefighters are recognized as Fully qualified Firefighters, the same as any Career department requires.
- 16 members of GVFD, 2 from Mudge, 4 from Decourcy, 3 from North Cedar participated in 115 - Structure Protection Sprinkler Course put on by BC Wildfire and held at GVFD hall #1.

This chart outlines the restrictions that may exist on a high risk activity.

Fire Danger Class identifies the three fire danger ratings for which there are restrictions: Danger Class III (moderate), IV (high) and V (extreme). Note: There are no restrictions on high risk activities when the fire danger rating is I (Very Low) or II (Low).

Restriction details restrictions for the various danger classes. For example, if the fire danger rating goes to IV (high), proponents of a high risk activity must "Implement a fire watch immediately after the high risk activity ends for a minimum of two hours." If the fire danger rating remains high for three consecutive days, a person carrying out a high risk activity must "cease activity between 1 p.m. PDT and sunset each day".

Duration describes the length of time that restrictions on high risk activities are in effect. For example, a person carrying out a high risk activity must "Implement a fire watch immediately after the high risk activity ends for a minimum of two hours" until "after the fire danger rating falls below Danger Class III", or in other words, until after the fire danger rating goes down to II (low) or lower.

Once we have those positions filled, we will have a Lieutenant on each of the four platoons that will oversee organizing and scheduling each platoon for their shifts. After the lieutenants are in place, we will look to fill the Training Officers position for a year.

The department is making all preparations for the retest on the superior tanker accreditation. I will be booking the test for March when the water table is high.

Our Day Firefighter program opens in January; two spots are available, Junior and Senior position. The program is in place to have members of the Department clean, maintain hall and apparatus and conduct service tests while being response ready in 90 seconds.

I advertised for a training officer within the Gabriola Fire Department no one applied, next step I will advertise in the Sounder and on our website.

Fire Chief Report Continued:

I have been working on the proposal to replace #4 our 1995 bush trucks for the last year and half, from 2021-2022 the cost of apparatus went up by 25% and we had to put off the project for a year to save more money in our capital reserve. The apparatus I propose is a wildland urban interface engine which will serve two purposes: one, a nibble 4x4 truck with wildfire fighting capability including, pump and roll with a rear mounted pump. Second a ULC (Underwriter Laboratories of Canada) rated First line engine serving Albert Reed Memorial Fire Hall #1 for the next 20 years.

A first line engine and tender within 20-year service life are required at each of the Gabriola fire halls to maintain Gabriola Island's Fire Underwriter Study and the insurance savings for the community. Proposal #1 Option 1. Quotation amount with FGFT providing the complete truck including the Freightliner chassis: \$723,210.00 CAD + taxes.

Option 2. If you purchased the apparatus body / plumbing from Fort Garry only (chassis supplied by others), the price would be \$517,899.00 CAD + taxes.
